#### WHAT IS THE PURPOSE OF THIS UPDATE?

#### **DESCRIPTION OF THIS FUND**


The Cash Fund invests in cash and cash equivalents. These may include investments issued by New Zealand-registered banks, the New Zealand Government, corporations or local authorities, or non-New Zealand governments.

The Cash Fund aims to achieve (after the fund charge and before tax) over the short term lower but stable returns, allowing for smaller ups and downs in value.

#### WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the Cash Fund:



# **EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR**

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$409 (that is 4.09% of her initial \$10,000). Sarah did not pay any other charges. This gives Sarah a total return after tax of \$409 for the year.




# Actual investment mix<sup>2</sup>
