DESCRIPTION OF THIS FUND


The International Property Fund invests mainly in international listed property assets. Investments may include companies, funds or trusts that invest in property and are listed or are soon to be listed, and cash and cash equivalents.

The International Property Fund aims to achieve a positive yearly return (after the fund charge and before tax) that over the long-term outperforms the relevant market index.

WHAT ARE THE RISKS OF INVESTING?



^{*}The manager expects that the fund charges for the next scheme year will be less than the fund charges disclosed in this fund update because the manager's basic fee was reduced effective 3 August 2023 from 1.00% to 0.95% per year.

EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$647 (that is 6.47% of her initial \$10,000). Sarah did not pay any other charges. This gives Sarah a total return after tax of \$647 for the year.


