WHAT IS THE PURPOSE OF THIS UPDATE?

This document tells you how the Equity Selection Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. DESCRIPTION OF THIS FUND

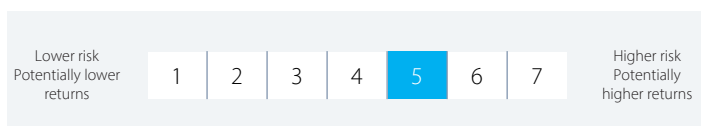
The Equity Selection Fund invests mainly in New Zealand and Australian equities. Investments may include equities in companies that are listed or intend to list on the New Zealand or Australian stock exchanges, and cash and cash equivalents.

The fund aims to achieve a positive yearly return (after the fund charge and before tax) that over the long-term outperforms the relevant market index.

WHAT ARE THE RISKS OF INVESTING?

Risk indicator for the Equity Selection Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

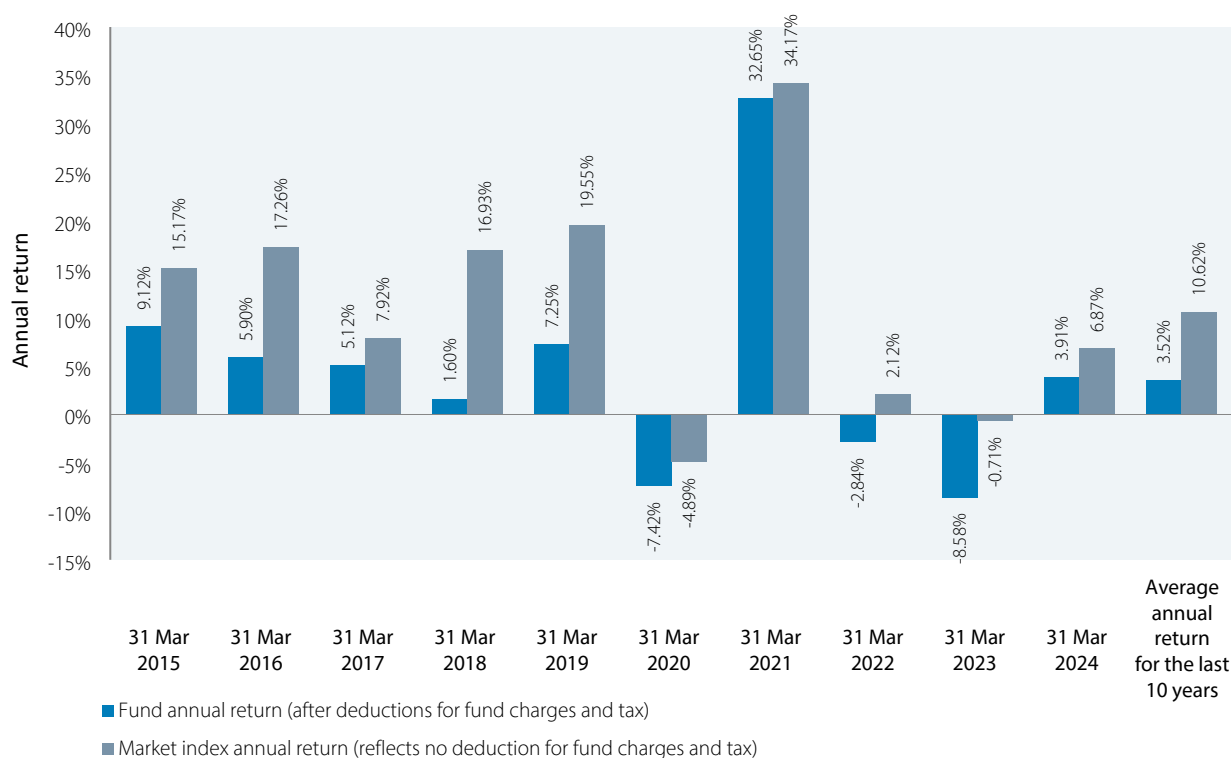
HOW HAS THE FUND PERFORMED?

*The manager expects that the fund charges for the next scheme year will be less than the fund charges disclosed in this fund update because the manager's basic fee was reduced effective 3 August 2023 from 1.10% to 0.95% per year.

Small differences in fees and charges can have a big impact on your investment over the long term.

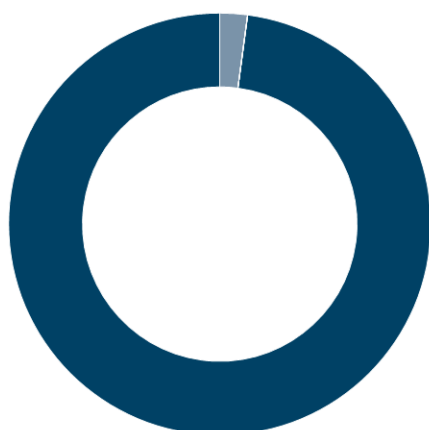
EXAMPLE OF HOW THIS APPLIES TO AN INVESTOR

Sarah had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Sarah received a return after fund charges were deducted of \$272 (that is 2.72% of her initial \$10,000). Sarah did not pay any other charges. This gives Sarah a total return after tax of \$272 for the year.

Actual investment mix²

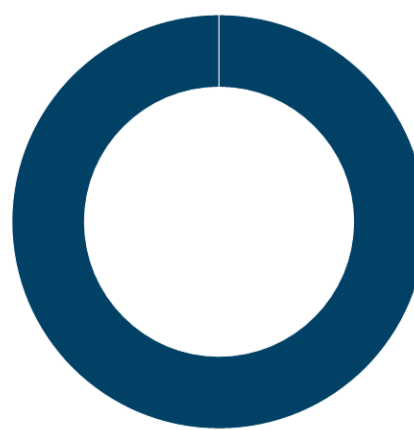
This shows the types of assets that the fund invests in.
