WHAT IS THE PURPOSE OF THIS UPDATE?

DESCRIPTION OF THIS FUND

The New Zealand Share Fund invests mainly in New Zealand equities. Investments may include equities in companies that are listed or intend to list on the New Zealand stock exchange, and cash and cash equivalents.

The fund aims to achieve a positive yearly return (after the fund charge and before tax) that over the long-term outperforms the relevant market index.

WHAT ARE THE RISKS OF INVESTING?



This gives Sarah a total loss after tax of \$246 for the year.




Actual investment mix²
